


## Portfolio objective

The portfolio aims to provide capital growth over the long term with a risk target of 65% - 95% of global equity volatility, as measured by the MSCI AC World Index. The portfolio invests in funds to gain exposure to equities and fixed income. The portfolio may also have some exposure to other asset classes including cash. The portfolio seeks to diversify the sources of return across global regions (which may include emerging markets) and investment approaches by investing in a range of active and passive funds managed by Invesco and other asset managers.

## Discretionary model portfolio service

Invesco's Discretionary Model Portfolio Service offers six model portfolios, each with a different risk-target. These managed model portfolios include funds invested across a variety of regions, asset classes and investment approaches - including active and passive investment strategies - with each model portfolio having a long-term investment horizon and diverse sources of returns.
